




Receita Bruta (R\$ MM)




EBITDA e Margem (R\$ MM)




Lucro Líquido e Margem (R\$ MM)





Banda Larga Fixa Jun/2024




Adições Líquidas - Banda Larga Jun/2023-Jun/2024










Rede em lajeado


Gross Revenue (BRL million)




EBITDA and Margin (BRL million)



Net Income and Margin (BRL million)






Recurring EBITDA and Margin (BRL million)




Market Share in Santa Catarina

Broadband – June 2024




Net Additions – Broadband

June 2023 to June 2024





- 45 days of technical team efforts in repairing networks and infrastructure["]




Internet network in Lajeado
