(I) Name and address of the relevant shareholder:

(II) The purpose of the acquisition and the interest is purely investment.

(III) On 9 June 2022 Norges Bank's holding in Kepler Weber SA shares (ISIN: BRKEPLACNOR1) fell below the 5% threshold and amounted to 4,429,474 shares or 4.93% based upon 89,860,065 common shares in issue. The threshold crossing does not alter the control or the administrative structure of Kepler Weber SA. Norges Bank does not have any other securities or derivatives referenced to shares held directly by Norges Bank.

(IV) Prior to crossing below the 5% threshold, Norges Bank held 4,551,774 common shares in Kepler Weber SA, equal to 5.07% of the total shares.

(V) No shareholders' agreement or contract regulating the right to vote or purchase and sale securities issued by the company exists.
